What information we collect, use, and why

We collect or use the following information for service updates or marketing purposes as well as operating and judging the HackSheffield 9 event:

- Names and contact details
- Marketing preferences
- Location data
- Recorded images, such as photos or videos
- Records of consent, where appropriate

We collect or use the following information for research or archiving purposes:

- Personal information used for the purpose of research
- Records of consent, where appropriate

We collect or use the following information for recruitment purposes:

- Contact details (eg name, address, telephone number or personal email address)
- Date of birth
- Any information included in a submitted CV

If you contact us, we collect or use the following personal information for **dealing with queries, complaints or claims**:

- Names and contact details
- Correspondence

Lawful bases and data protection rights

Under UK data protection law, we must have a "lawful basis" for collecting and using your personal information. There is a list of possible lawful bases in the UK GDPR. You can find out more about lawful bases on the ICO's website.

Which lawful basis we rely on may affect your data protection rights which are in brief set out below. You can find out more about your data protection rights and the exemptions which may apply on the ICO's website:

 - personal information required for security of venue to check names of actual attendees against registered attendees

Our lawful bases for collecting or using personal information for **research or archiving purposes** are:

- Consent we have permission from you after we gave you all the relevant information. All of your data protection rights may apply, except the right to object. To be clear, you do have the right to withdraw your consent at any time.
- Contract we have to collect or use the information so we can enter into or carry out a contract with you. All of your data protection rights may apply except the right to object.
- Legitimate interests we're collecting or using your information because it benefits you, our organisation or someone else, without causing an undue risk of harm to anyone. All of your data protection rights may apply, except the right to portability. Our legitimate interests are:
 - It is in our interest to monitor the diversity of hackathon events to ensure that they are serving the community well.

Our lawful bases for collecting or using personal information for **recruitment purposes** are:

- Consent we have permission from you after we gave you all the relevant information. All of your data protection rights may apply, except the right to object. To be clear, you do have the right to withdraw your consent at any time.
- Contract we have to collect or use the information so we can enter into or carry out a contract with you. All of your data protection rights may apply except the right to object.

Our lawful bases for collecting or using personal information for **dealing with queries, complaints or claims** when you contact us are:

• Consent - we have permission from you after we gave you all the relevant information. All of your data protection rights may apply, except the right to object. To be clear, you do have the right to withdraw your consent at any time.

Where we get personal information from

- Directly from you
- CCTV footage or other recordings

How long we keep information

Unless you specifically consent otherwise, your personally identifiable information will be retained for no longer than 6 months after the end of the HackSheffield 9 event.

Anonymised statistics may be retained for up to 2 years for the purposes of monitoring the demographics of event attendees.

Data processors we share information with

Tito (events management service)

This data processor does the following activities for us: Processing your registration information, food orders etc.

We have a joint controller relationship with HackSheffield sponsoring organisations. We process your personal information with that joint controller for the following reason: to provide CV information so that they may contact you regarding.

We also have a joint controller relationship with Major League Hacking and Hackathons UK Limited. We process your personal information with that joint controller for the following reason: to facilitate events administration, and so that they can compile demographic data on hackathon attendees across the world.. Others we share personal information with

- Emergency services, if necessary to deal with an emergency
- Publicly on our website, social media or other marketing and information media
- Other relevant third parties:
 - Employers who sponsor HackSheffield
 - o University of Sheffield if required for security purposes
 - o Hackathons UK
 - Major League Hacking

Sharing information outside the UK

Where necessary, we may transfer personal information outside of the UK. When doing so, we comply with the UK GDPR, making sure appropriate safeguards are in place.
